APPLICATION FOR MEMBERSHIP

Article VII-Membership

Any male person age twenty-one years or older is eligible for membership. The number of members shall be as authorized by the Board of Trustees.

Applications for membership shall be in writing, in a form prescribed by the Trustees, and shall be signed by the applicant who shall be recommended by at least one member of the Club. All applications for membership shall be filed with the General Manager. The Board of Trustees shall pass on all applications for membership; shall make a careful examination as to the qualifications of all applicants, shall receive, consider and treat confidential all communications in reference to such applicants, and shall pass separately upon each name submitted. All proceedings of the Board of Trustees relative to applicants for membership shall be secret and confidential, and a person shall become a member of the Club only upon the favorable vote of a majority of the Trustees present at a regular or special meeting of the Board. No person whose name has been proposed for membership and has been rejected by the Board of Trustees shall be renominated within twelve months from the date of such rejection.

All resignations shall be made in writing and in person to the General Manager, and shall not become effective unless and until the resigning member has paid his indebtedness to the Club. Any credit balance on the resigning member's account due to unused personal training, tanning, lockers, and massage contracts shall be forfeited by the resigning member. Dues paid relating to months not yet expiring shall also be forfeited.

Any member resigning his membership, may within a period of one year from acceptance of his resignation, make application to the Board of Trustees and be restored to membership upon the payment of dues accruing since his resignation. No new initiation fees would apply.

A member whose conduct has been adjudged by a majority of the Trustees to be unbecoming shall forthwith be denied the privileges of membership and his name shall be stricken from the roster of members.
